## 1. Scope

This addendum applies until further notice.

Unless covered in this addendum, our normal behaviour policy continues to apply.

We may need to amend or add to this addendum as circumstances or official guidance changes. We will communicate any changes to staff, parents and students.

## 2. Expectations for students in school

### 2.1 New rules

When students are in school, we expect them to follow all of the rules set out below to keep themselves and the rest of the school community safe.

Staff will be familiar with these rules and make sure they are followed consistently.

Parents should also read the rules and ensure that their children follow the new procedures that have been put in place. Parents should contact Mr Mckendrick (Deputy Headteacher) if they think their child might not be able to comply with some or all of the rules, so we can consider alternative arrangements with them.

#### Routines

- Students will arrive in full school uniform at school at 10 am and will finish school at 12pm.
- Students will adhere strictly to the 2m social distancing guidance provided by the government.
- Students will follow the one-way system set out by the school.
- Students will be expected to use the equipment that they have brought to school themselves or that has been provided to them by the school. There will be no sharing of equipment.
- Bottled water will be provided to the students
- There are no planned breaks, so students will be expected to remain in the areas of the school they are allocated to.

#### Hygiene

- Students will use the hand sanitiser provided by the school when entering the classroom.
- Students will be expected to cover their mouth while sneezing and/or coughing.(Catch it, kill it, bin it)
- Students will regularly wash their hands, especially after using the toilets and re-entering the classroom.
- Students under no circumstances will cough or spit at or towards one another

#### Other

- Students will be expected to inform a member of staff if they experience symptoms of coronavirus

## **2.2 Rewards and sanctions for following rules**

To help encourage students to follow the above rules, we will continue to reward students in accordance to the behaviour policy with a key focus on parental contact. However, if students fail to follow the processes set out in this document and/or the behaviour policy, they will be deemed as putting other students or staff at risk. This will result in contact home and the student being asked to leave the premises in accordance to the risk assessment.

## **2.3 Changed rules**

As long as this addendum applies, we will alter the following school rules.

- Families who make the decision to keep their children at home will be supported by the school, however, if a family has indicated that their child will be attending school and they do not arrive, they will receive a phone call from the school to ascertain a reason for this non-attendance.
- Full school uniform will apply, however, school bags must not be brought to school.

## **3. Monitoring arrangements**

We will review this policy as guidance from the local authority or Department for Education is updated, and as a minimum of every 3 to 4 weeks by Paul McKendrick. At every review, it will be approved by the full governing board.
