1. Scope

This addendum applies until further notice.

Unless covered in this addendum, our normal behaviour policy continues to apply.

We may need to amend or add to this addendum as circumstances or official guidance changes. We will communicate any changes to staff, parents and students.

2. Expectations for students in school

2.1 New rules

When students are in school, we expect them to follow all of the rules set out below to keep themselves and the rest of the school community safe.

Staff will be familiar with these rules and make sure they are followed consistently.

Parents should also read the rules and ensure that their children follow the new procedures that have been put in place. Parents should contact Mr Mckendrick (Pastoral Deputy Headteacher) via admin@kirkbyhghschool.net if they think their child might not be able to comply with some or all of the rules, so we can consider alternative arrangements with them.

Routines

- Students will arrive in full school uniform at school at 8.45 am and will finish school at 3pm. Key stage 4 will have lunch from 2pm until 3pm and are free to leave the premises as agreed with parents
- Students will adhere strictly to any social distancing guidance provided by the government or the school.
- Students will follow entrance, exit and movement systems set out by the school. This is regularly reviewed and the risk assessment addendum is updated in accordance with changes.
- There will be no sharing of equipment.
- Bottled water will be provided to students. Water fountains will be switched off.
- Students will be expected to remain in the areas of the school they are allocated to for entrance, exit, breaks and lunches.

Hygiene

- Students will use the hand sanitiser provided by the school when entering the classroom.
- Students will be expected to cover their mouth while sneezing and/or coughing. (Catch it, kill it, bin it)
- Students will regularly wash their hands, especially after using the toilets and re-entering the classroom.
- Students under no circumstances will cough or spit at or towards one another

Other

- Students will be expected to inform a member of staff if they experience symptoms of coronavirus

2.2 Rewards and sanctions for following rules

To help encourage students to follow the above rules, we will continue to reward students in accordance to the behaviour policy with a key focus on parental contact. However, if students fail to follow the processes set out in this document and/or the behaviour policy, they will be deemed as putting other students or staff at risk. This will result in contact home and the possibility of the student being asked to leave the premises in accordance with the risk assessment.

3. Monitoring arrangements

We will review this policy as guidance from the local authority, Department for Education or RLT is updated by Mr McKendrick. At every review, it will be approved by the full governing board.
